3. Introduction

The netLex Platform uses a technology called "Cookies," which can be defined as a set of information that a website can store on your device. Once these pieces of information are stored, they will be provided by your browser whenever you access our website, ensuring that your preferences are applied.

4. **How We Use Cookies**

Cookies allow us to recognize your preferences, for example, to understand, diagnose, troubleshoot, and correct issues with the Platform. The collection of this information is intended to enhance the User experience and provide support services for Platform usage, as well as to enable the execution of activities and the management of history within the Platform.

Cookies typically have an expiration date. For example, some Cookies are automatically deleted when you close your browser (known as session Cookies), while others can be stored on your computer for a longer period until manually deleted (referred to as persistent Cookies).

We only collect essential data via Cookies for the proper functioning of our website and for access metrics analysis. In this regard, we use Cookies for data storage with the following purposes:

Authentication	We use cookies when the user accesses the platform. This helps us avoid requiring login on subsequent pages.
Notification	We use session Cookies for sending communications through notifications, as well as for requesting evaluations using the Net Promoter Score (NPS) methodology, which is a customer satisfaction indicator collection method aimed at identifying product and service improvement opportunities.
Operation	We use Cookies that are essential for the functioning of our platform, ensuring its security and proper performance, without which it would not work correctly.
Analysis	We use Cookies to enable the submission of requests to participate in the Net Promoter Score (NPS) survey, which is a methodology for collecting customer satisfaction indicators aimed at identifying opportunities for improvement in our product and services.



Research	We use Cookies to enable the submission of requests to participate in the NPS (Net Promoter Score) survey, which is a methodology for collecting customer satisfaction indicators with the aim of identifying opportunities for improvement in our product and services.
Support	We use Cookies to provide support for the use of the netLex Platform.
